The AP4000 access point is a high-performance 802.11ax Wi-Fi 6E access point. Designed for high-density indoor environments, it can operate in 6 GHz, 5 GHz, and 2.4 GHz bands.

The access point supports IEEE 802.11ax Orthogonal Frequency-Division Multiple Access (OFDMA) multi-user access.

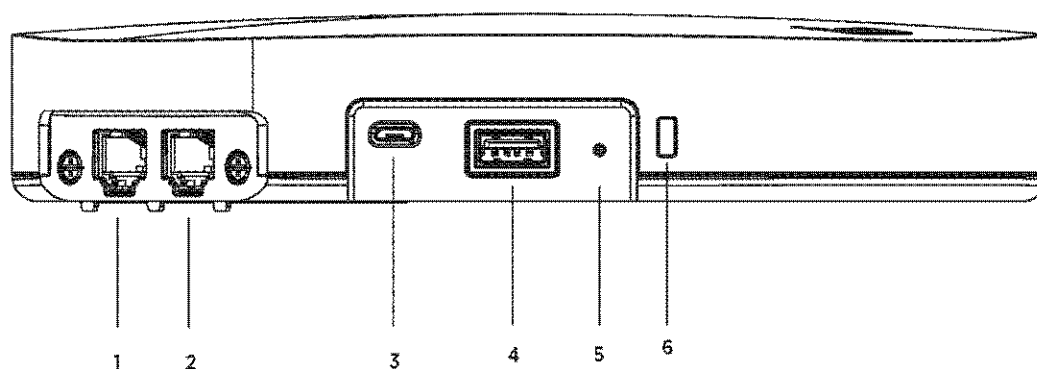
## AP4000 Features and Specifications

### Features

The access point has the following hardware components:

The access point has the following features:

- One multicolor LED status light

- One light sensor located at the top of the device
- Two Ethernet ports - Eth0 and Eth1

Ethernet ports (Eth0 and Eth1) automatically negotiate half- and full-duplex connections with the connecting device.

- Eth0: 100/1000/2500 Mbps auto-negotiation Ethernet port, RJ45, Power over Ethernet (PoE) at 802.3at
- Eth1: 10/100/1000 Mbps auto-negotiation Ethernet port, RJ45

These ports are auto-sensing and adjust to straight-through and crossover standard Cat5e or better Ethernet cables automatically. The access point receives power through an Ethernet connection to the Eth0 port from power sourcing equipment (PSE) that is compatible with the 802.3at and 802.3at standards.

- One USB port

Use the USB port to connect USB-based beacons such as iBeacon and Internet of Things (IoT) devices. Remove the screw that secures the protective cover to access the USB port.

- One micro USB console port

Through the console port, you can make a serial connection between your management system and the access point.



#### Note

When you connect to the device using the micro USB Console port, the management station from which you connect to the device must have a VT100 emulation program, such as Tera Term Pro (a free terminal emulator) or Hilgraeve HyperTerminal (provided with Windows operating systems from XP forward).

- One reset button
- One Kensington lock



#### Tip

The best practice is to use Kensington locks for locking the device.

The AP4000 access point has one status light on top of the chassis. The status light conveys operational states for system power, firmware updates, Ethernet and wireless interface activity, and major alarms.

### About This Task

The access point ships with the AH-ACC-BKT-AX-TB mounting bracket for standard 15/16 in. dropped ceiling grid or for 9/16 in. wide and flat T-bar, and for walls or solid surfaces with the appropriate mounting hardware. 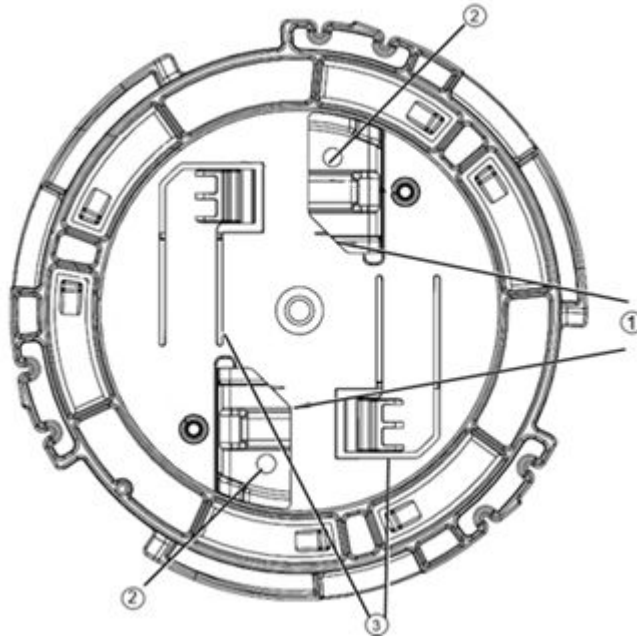
The bracket and the access point have a red dot on the back that acts as a guide during installation.

To install the access point:

### Procedure

1. Remove the ceiling tiles.

- Align the bracket on the ceiling rail in such a way that the bracket metal angled cuts are parallel to the sides of the ceiling rail.

Callout	Description
1	Metal angled cuts
2	Wall mount holes

- Rotate the bracket clockwise until the metal angled cuts on the back of the bracket hook over the edge of the ceiling rail and the white tabs click in place.



**Note**

There are two white tabs in the back of the bracket that holds on to the ceiling rail in place. Use your finger to push and unhook one side of the white tab if you want to remove the accessory from the ceiling rail.

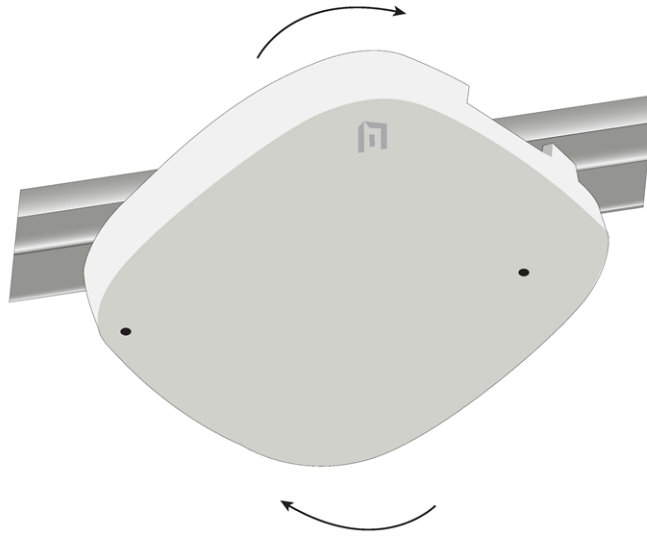
- Attach the Ethernet port cap to the access point Ethernet port.
- Align the red dot on the back of the access point against the red dot on the bracket.



**Note**

The bracket has a center circular tip that fits into the circular dip on the back of the access point.

6. Press and rotate the access point 1/8th turn clockwise until it clicks into place on the bracket.

7. Attach the Cat6 RJ45 cable to the Eth0 or Eth1 port.
8. Place the cable cover over the Ethernet cable.
9. Replace the ceiling tiles.

- Two anchors, if needed

### About This Task

The access point can be installed on a wall or a solid surface using the AH-ACC-BKT-AX-TB bracket paired with two screws and screw-in anchors, if needed.

To install the access point:

Procedure

1. Place the AH-ACC-BKT-AX-TB bracket on a wall or a solid surface, and mark and drill two mounting holes.

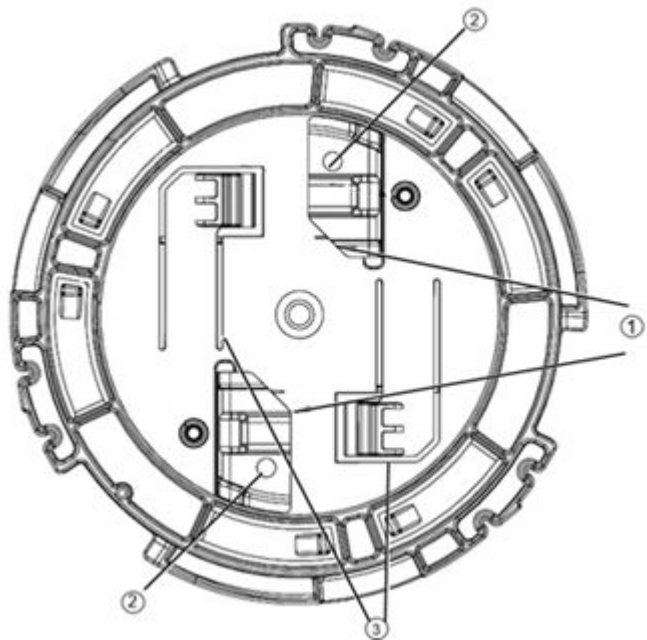


Figure 4: AH-ACC-BKT-AX-TB bracket with wall mounting holes

2. Attach the bracket to the wall using two screws.  
Use screw in anchors, if needed.
3. Attach the Ethernet port cap to the access point Ethernet port.
4. Align the red dot on the back of the access point against the red dot on the bracket.

The bracket has a center circular tip that fits into the circular dip on the back of the access point.

5. Press and rotate the access point 1/8th turn clockwise until it clicks into place on the bracket.
6. Attach the Cat6 RJ45 cable to the Eth0 or Eth1 port.
7. Place the cable cover over the Ethernet cable.








If you are using an indoor access point, you can secure it by using the Kensington lock on the side of the access point. The security feature is used to prevent the access point from being removed from the mounting accessory.

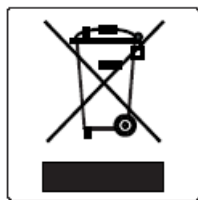
