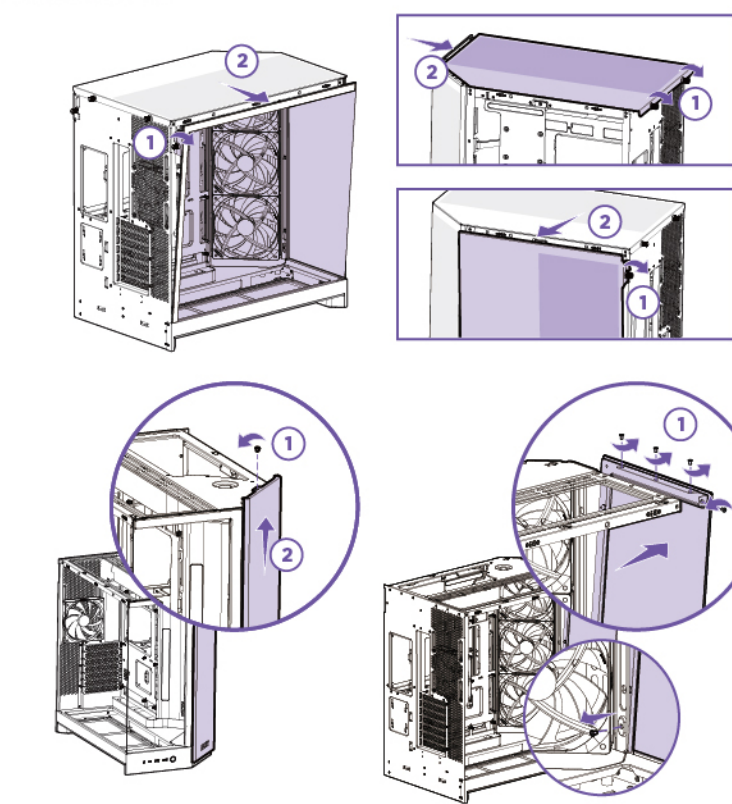

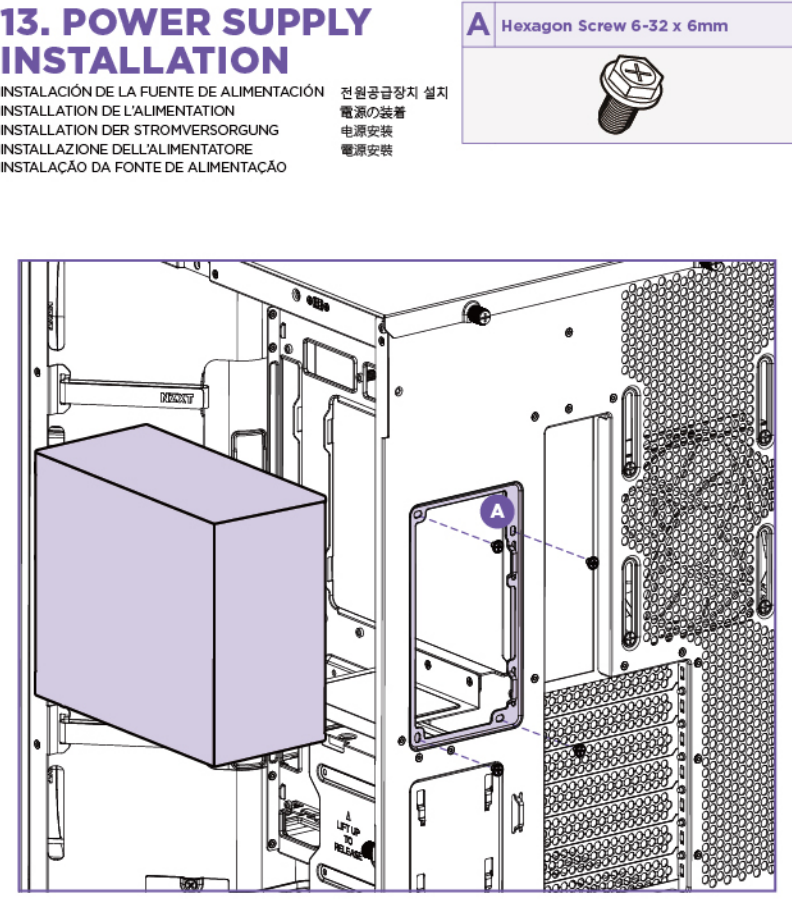

This warranty gives you specific legal rights.
