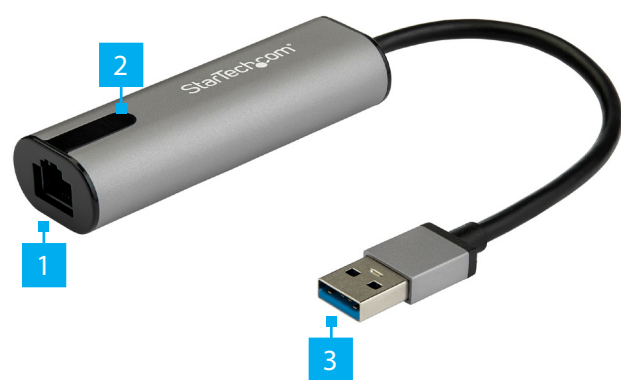


USB-A™ 2.5Gb NBase-T Network Adapter

Port/LED		Function
1	RJ45 Port	Used to connect to a Network Device.
2	LED	Solid Blue: Indicates that the CAT5/6a cable is connected to the RJ45 port with a link speed of 2.5Gbps. Solid Green: Indicates that the CAT6a cable is linked to the RJ45 port with a link speed of 1Gbps/100Mbps/10Mbps. Off: Indicates no connection.
3	USB-A Connector	Used to connect the Network Adapter to the Host Computer.

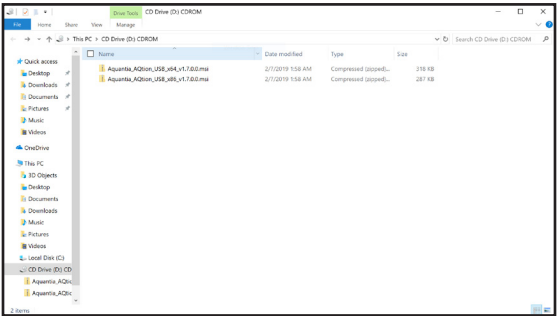
Installation

Hardware Installation

1. Connect a **CAT5/6a Cable** to the **RJ45 Port** on the **Network Adapter** and to a **Network Device**.
2. Connect the **USB-A Connector** on the **Network Adapter** to a USB-A port on the **Host Computer**.

Driver Installation

1. If the **Drivers** do not automatically download when you connect the **Network Adapter** to the **Host Computer**, a message that a **Virtual CD** is loaded will appear.
2. Click on the message, the **CD Drive** screen will open.

3. Click on the folder that is compatible with your **Host Computer** and run the **RTK_NIC_DRIVER_INSTALLER** file to begin the background installation.
