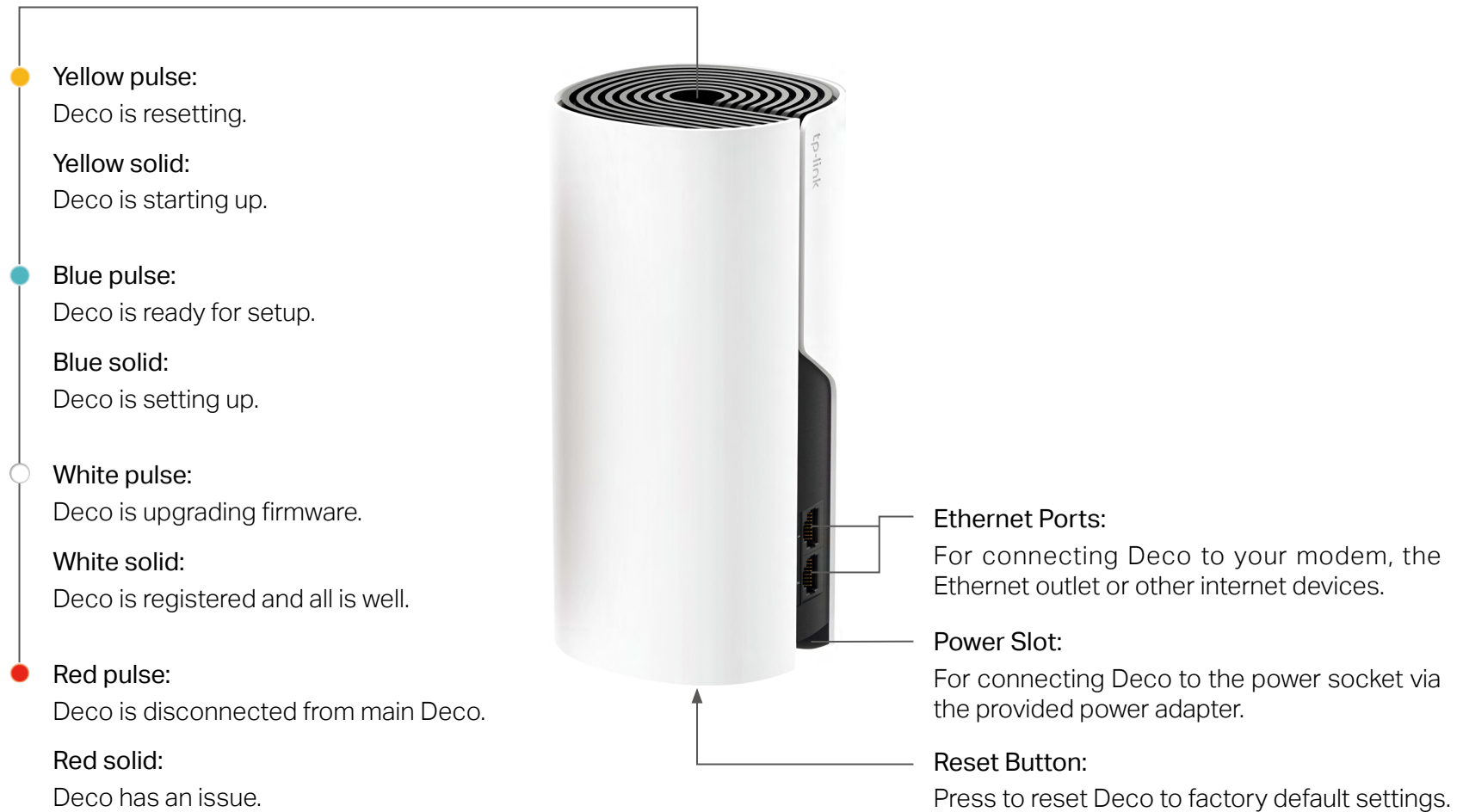

Install the app on your Android or iOS smartphone or tablet.



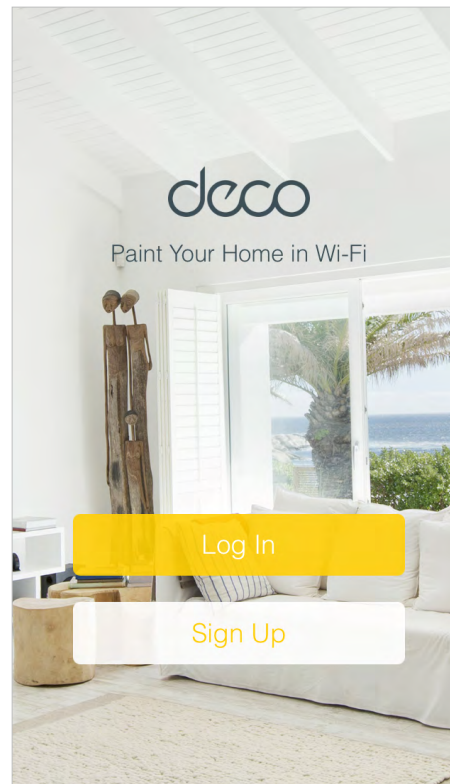

Open the app. Use your TP-Link ID to log in.

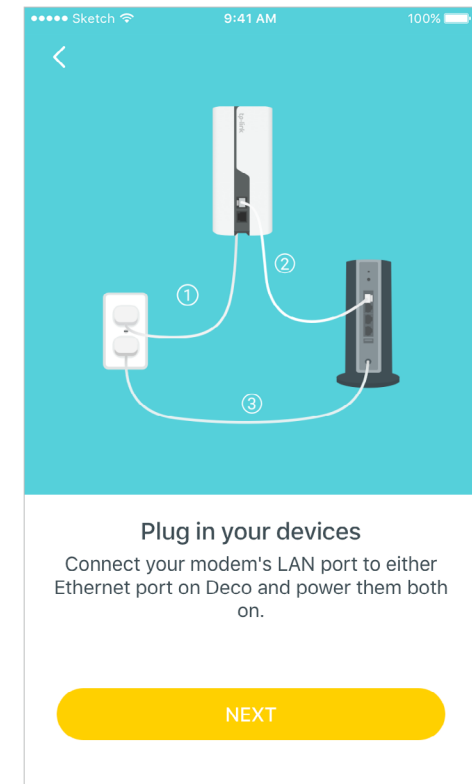

## 3. Connect Deco to your modem


Find and power off your modem. Connect your Deco to the modem and power them both on.

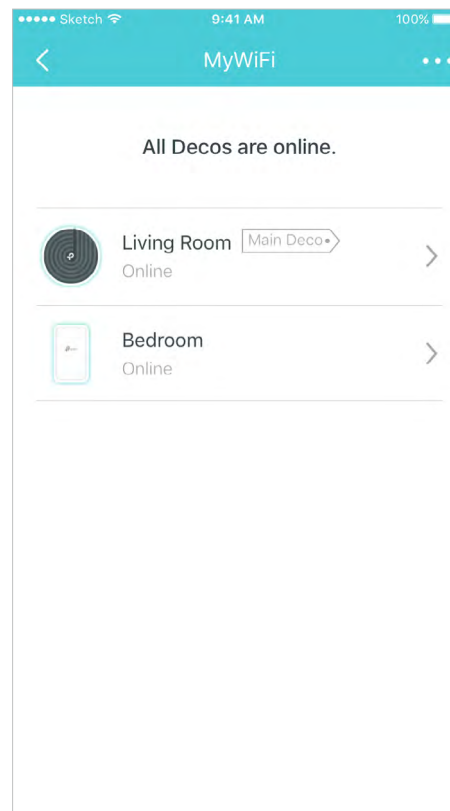
# Dashboard

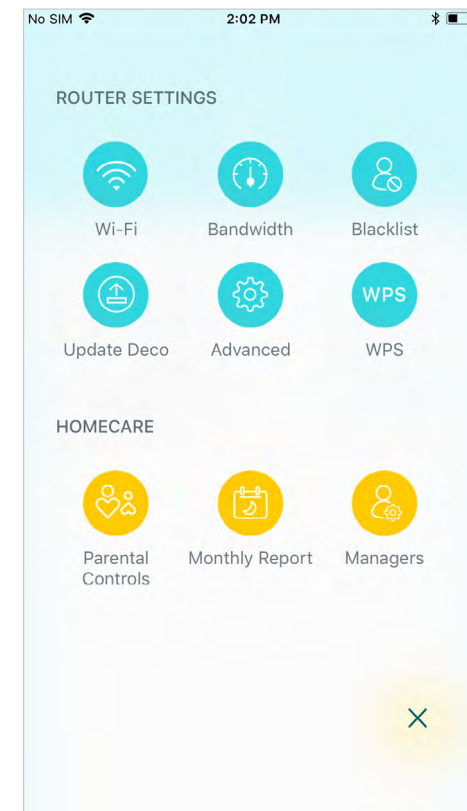
